IN THE EVENT THAT WE CEASE OFFERING DEALER AGREEMENTS FOR THE 5. ESTABLISHMENT AND OPERATION OF NEW CAR SALES BUSINESSES IN THE 50 UNITED STATES, WE WILL HAVE THE RIGHT TO TERMINATE THE DEALER AGREEMENT AND ALL RIGHTS UNDER IT UPON NOT LESS THAN 6 MONTHS PRIOR WRITTEN NOTICE TO YOU.

6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
