The franchise offered is for the operation of a retail dry cleaning business under the "Tide Dry Cleaners" trademark offering premium dry cleaning, laundering, and related fabric and garment care services and products.

The total estimated investment necessary to begin operation of a Tide Dry Cleaners franchise is \$638,500 to \$1,333,500. This includes between \$95,000 and \$155,000 that must be paid to the franchisor or its affiliate You also might pay the franchisor \$20,000 multiplied by the number of future franchised outlets that you intend to develop if you sign a development rights agreement with the franchisor for multi-unit development.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or its affiliate in connection with the proposed franchise sale.
