Tilford's Franchise, LLC is offering Tilford's Wood Fired Pizza franchises. As a franchisee, you will operate a TILFORD'S Business providing pizza, hot sandwiches, salads, and other food and drink items via a mobile wood fired oven for catering to parties, corporate events, state fairs, festivals and other events, and at recurring location such as farmer's markets and sidewalk and street vendor locations, all according to the terms, conditions, methods, and system standards indicated in the Franchise Agreement and corresponding operations manual.

The total investment necessary to begin operation of a TILFORD'S Business franchise ranges from \$107,000 to \$151,000. This includes between \$41,600 and \$42,500 that must be paid to the franchisor or its affiliates, including the initial franchise fee.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.** 

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind. More information on franchising, such as "A Consumer's Guide to Buying a Franchise," which can help you understand how to use this Franchise Disclosure Document, is available from the Federal Trade Commission.
