The franchise is for the establishment and operation of a café offering customers high quality Pan-Asian cuisine made fresh in the store using proprietary recipes and incorporating Thai, Japanese, Chinese and Vietnamese elements and menu items (a “**Tin Drum® Asian Kitchen franchise**” or “**Tin Drum® Asian Kitchen Store**” or “**Franchised Business**”).

The total investment necessary to begin operation of a single -unit Tin Drum® Asian Kitchen franchise ranges from \$407,800 to \$563,000. This includes \$32,500 that must be paid to us. If a franchisee chooses to develop multiple units, \$22,500 of additional fees must be paid to us for the second and each additional unit.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT OF STATE MEDIATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE OR LITIGATE WITH US IN GEORGIA THAN IN YOUR OWN STATE.**

3. **UPON EARLY TERMINATION OF THE FRANCHISE, YOU MUST PAY US LIQUIDATED DAMAGES IN AN AMOUNT EQUAL TO THE AVERAGE MONTHLY ROYALTY FEES DURING THE TWELVE MONTHS PRIOR TO TERMINATION MULTIPLIED BY 18 OR THE NUMBER OF MONTHS REMAINING IN THE FRANCHISE AGREEMENT, WHICHEVER IS LESS.**
4. **THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.**

We use the services of one or more **FRANCHISE BROKERS** or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. With the exception of referrals in the state of Washington, we pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
