The franchise offered is for the operation of a Tippi Toes Dance facility, hereinafter, referred to as Tippi Toes. The franchise will conduct lessons and courses in dance for children ages 18 months to 12 years of age.

The total investment necessary to begin operation of a Tippi Toes Franchise is between \$50,000 and \$61,500. This includes the \$30,000 initial franchise fee and \$3,000 training fee that must be paid to the franchisor. This sum does not include rent for a business location.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. 
