The franchise is for the establishment and operation of a TITLE BOXING CLUB® Fitness Facility that offers total body workouts that are effective and fun, taught by Title Boxing Club Certified Trainers.

The total investment necessary to begin operation of a TITLE BOXING CLUB® Fitness Facility ranges from ~~\$156,356~~165,350 to ~~\$378,035~~394,827. This estimate does not include the cost of buying or leasing the location of your TITLE BOXING CLUB® Fitness Facility. The range of investment does include an initial franchise fee of \$35,000 for each TITLE BOXING CLUB® Fitness Facility and ~~\$67,456~~74,950 to ~~\$104,735~~115,027 for the Standard Initial Package both of which must be paid to us.
