The franchise is for the establishment and operation of a TITLE BOXING CLUB® Fitness Facility that offers total body workouts that are effective and fun, taught by Title Boxing Club Certified Trainers.

The total investment necessary to begin operation of a TITLE BOXING CLUB® Fitness Facility ranges from ~~\$165,350~~ \$143,256 to ~~\$394,827~~ \$394,227. This estimate does not include the cost of buying ~~or leasing~~ the location of your TITLE BOXING CLUB® Fitness Facility. The range of investment does include an initial franchise fee of \$35,000 for each TITLE BOXING CLUB® Fitness Facility ~~and \$74,950 to \$115,027~~ (the initial franchise fee is reduced to \$29,000 per Franchise Agreement if you sign Franchise Agreements for three or more Fitness Facilities at the same time or if you enter into an Area Development Agreement to develop three or more Fitness Facilities), an initial training fee of \$5,000 and \$67,456 to \$89,027 for the Standard Initial Package ~~both~~ all of which must be paid to us.

The total investment necessary to begin operation as a developer under an Area Development Agreement is \$70,000 to \$290,000 and includes payment to us of the development fee of \$29,000 per Fitness Facility if you agree to develop three or more Fitness Facilities or \$35,000 per Fitness Facility if you agree to develop two Fitness Facilities. The area development fee applicable to each Fitness Facility will be credited toward the initial franchise fee due under the Franchise Agreement for each Fitness Facility.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with a proposed franchise sale.
