The franchise offered is for a TONI&GUY hairdressing academy ("TONI&GUY Hairdressing Academy"), which is a hairdressing/cosmetology school

The total investment necessary to begin operation of a new TONI&GUY Hairdressing Academy franchised business is estimated to be between \$585,000 and \$1,568,500 (excluding real estate costs), which includes the \$155,500 to \$395,500 which you must pay to us or our affiliates. The total investment necessary to begin operation of a conversion academy (excluding real estate costs) is between \$159,000 and \$599,000, which includes the \$41,500 to \$180,500 which you must pay to us or our affiliates.

This Disclosure Document summarizes certain provisions of your Fianchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale.
