The franchise offered is for a hairdressing academy/cosmetology school operating under the name “TONI&GUY Hairdressing Academy | TIGI Creative School.”

The total investment necessary to begin operation of a new franchised business is estimated to be between \$463,000 and \$1,506,000 (excluding real estate costs), which includes \$145,500 to \$410,500 you must pay to us or our affiliates. The total investment necessary to begin operation of a conversion franchised business (excluding real estate costs) is between \$144,500 and \$531,500 which includes \$40,500 to \$195,500 you must pay to us or our affiliates. These estimated figures are based on a 8,500 to 12,500 square foot salon.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this Disclosure Document.**

4. **YOU MUST COMPLY WITH MAXIMUM PRICES SET BY THE FRANCHISOR FOR THE GOODS AND SERVICES YOU SELL. THIS REQUIREMENT MAY REDUCE YOUR ANTICIPATED REVENUE AND NET INCOME.**
5. **THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.**

We may use the services of one or more **FRANCHISE BROKERS** or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
