The franchise offered is for a hairdressing academy/cosmetology school operating under the name “TONI&GUY Hairdressing Academy | TIGI Creative School ”

The total investment necessary to begin operation of a new franchised business is estimated to be between \$466,500 and \$1,511,500 (excluding real estate costs), which includes \$140,500 to \$390,500 you must pay to us or our affiliates. The total investment necessary to begin operation of a conversion franchised business (excluding real estate costs) is between \$148,000 and \$537,000 which includes \$35,500 to \$175,500 you must pay to us or our affiliates. These estimated figures are based on a 8,500 to 12,500 square foot salon.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this Disclosure Document.**

- 1 THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS BE LITIGATED IN DALLAS, TEXAS. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN DALLAS, TEXAS THAN IN YOUR HOME STATE
- 2 THE FRANCHISE AGREEMENT STATES THAT TEXAS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS
- 3 THE FRANCHISEE WILL FACE COMPETITION FROM OTHER FRANCHISES, FROM AFFILIATE OWNED ACADEMIES, FROM FRANCHISEE OWNED STORES, AND THROUGH PRIVATE LABEL PRODUCTS AND MERCHANDISE IN OTHER CHANNELS OF DISTRIBUTION
- 4 YOU MUST COMPLY WITH MAXIMUM PRICES SET BY THE FRANCHISOR FOR THE GOODS AND SERVICES YOU SELL. THIS REQUIREMENT MAY REDUCE YOUR ANTICIPATED REVENUE AND NET INCOME
- 5 AS PER THE AUDITED BALANCE SHEET DATED DECEMBER 31, 2016, THE FRANCHISOR HAD A WORKING CAPITAL DEFICIENCY (CURRENT ASSETS MINUS CURRENT LIABILITIES) OF \$31,621
- 6 THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$148,000 to \$1,511,500 PLUS REAL ESTATE COSTS. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDERS EQUITY AS OF DECEMBER 31, 2016, WHICH IS (\$2,319)
- 7 THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE

We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
