The franchisee will operate a chef driven fast food restaurant under the name "Top Round Roast Beef" that features top round roast beef sandwiches and frozen custard

The total investment necessary to begin operations of a single restaurant ranges from \$265,000 to \$520,000. This includes a \$35,000 franchise fee which must be paid to the franchisor or affiliate. We also offer to qualified applicants the right to develop multiple restaurants within a development territory. The total investment necessary to begin operations as an area developer with rights to develop between 2 and 5 restaurants ranges from \$285,000 to \$600,000. This includes a \$35,000 franchise fee for the first restaurant and an area developer fee of between \$20,000 and \$80,000, depending on how many restaurants you commit to develop, that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
