

Total Woman Franchising, Inc ("Total Woman Gym+Spa") franchisees will operate a s combined gym and day spa operating under the name "Total Woman Gym+Spa" hereinafter referred to as TOTAL WOMAN Gym + Spa, and / or TOTAL WOMAN, and / or Franchise Location, and / or Location, and or Gym+Spa

We offer two franchise options

- A Single Franchise Location The franchise is to develop and operate a membership-based, upscale, full-service, combined gym and spa primarily for women focusing on health, fitness and wellness services with accommodations for childcare, The total estimated investment necessary to begin operation of a TOTAL WOMAN Gym+Spa franchise ranges from \$8600,500 to \$1,48300,500 This includes \$30,000 as an initial franchise fee to be paid to us upon signing your franchise agreement
- Multiple Franchise Locations We offer an Area Development Agreement ("ADA") that requires you to develop more than one Location within a defined geographical area. The total estimated investment necessary to begin operation of a franchised location under an ADA includes a development fee equal to \$10,000 times the number of franchise locations you commit to open under the ADA. This fee is payable upon signing the ADA. For each franchise location that you develop and open on schedule we credit you \$10,000 towards the initial franchise fee for that Franchise Location. The estimated investment necessary to begin operation of each franchise location is \$860,500 to \$1,483,000,500. For each franchise location, this includes \$30,000 to be paid to us as the initial franchise fee for that facility (less the \$10,000 credit, if applicable).

This Disclosure Document summarizes certain provisions of your franchise agreement and other information Read this Disclosure Document and all accompanying agreements carefully You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the



franchisor or an affiliate in connection with the proposed franchise sale Note, however, that no governmental agency has verified information contained in this document
