Totally Nutz businesses sell fresh roasted cinnamon glazed nuts and related products at various venues, events, and mall locations ("Totally Nutz Businesses").

The total investment necessary to begin operation of a Totally Nutz Business is between \$57,372 and \$246,000, including between \$30,300 and \$130,500 that must be paid to the franchisor or its affiliates.
