The member will operate a Trademark Collection Hotel guest lodging facility offering overnight accommodations and related services.

The total investment necessary to begin operation of a Trademark Collection Hotel for a new construction project ranges from the low end of \$7,468,158 for a 100 room Trademark facility to the high end of \$12,171,486. The total investment necessary to begin operation of a Trademark membership if you already own a facility typically ranges from the low end of \$208,867 for a 100 room Trademark facility to the high end of \$4,136,713. Land acquisition costs are not included in these ranges. The above amounts include a range of \$43,500 to \$65,175 that must be paid to TMH Worldwide, LLC or its affiliate(s).

THIS GUARANTEE WILL PLACE BOTH YOU AND YOUR SPOUSE’S MARITAL AND PERSONAL ASSETS, PERHAPS INCLUDING YOUR HOUSE, AT RISK IF YOUR FRANCHISE FAILS.
5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
