The franchisee will operate a Travelodge[®] guest lodging facility franchise offering overnight accommodations and related services.

The total investment necessary to begin operation of a Travelodge franchise for a 100 room new construction facility ranges from \$4,288,121553,770 to \$7,268,731491,200. The total investment necessary to begin operation of a Travelodge franchise for a 100 room conversion facility ranges from \$162,218172,670 to \$1,894,661. Land acquisition costs are not included in these ranges.954,600. The above amounts include a range of \$54,548\$41,400 to \$81,74542,900 that must be paid to the franchisor or an affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully.
