5. THE FRANCHISE MAY BE TERMINATED IF YOUR FRANCHISED BUSINESS IS NOT OPERATING WITHIN 90 DAYS OF SIGNING THE AGREEMENT, UNLESS WE HAVE AGREED OTHERWISE IN WRITING.

6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
