The Taylor Rental and Grand Rental Station franchises we offer are to operate a rental store.

The total investment necessary to begin operation of a rental store franchise is \$608,550 to \$1,973,750. This includes \$6,300 that must be paid to us, and between \$356,100 and \$1,530,100 you must pay to our parent, assuming you purchase your opening inventory from our parent, otherwise, the amount paid to our parent is between \$6,100 and \$30,100.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
