The franchisee will operate a TRYP by Wyndham<sup>®</sup> guest lodging facility, offering overnight accommodations and related services.

The total investment necessary to begin operation of a TRYP by Wyndham franchise for a 150 room new construction facility ranges from  $\frac{13,197,947}{13,197,947}$  to  $\frac{22,345,559}{12,998,866}$  to  $\frac{22,911,446}{12,998,866}$ . The above amounts include \$ that must be paid to the franchisor or an affiliate. The total investment necessary to begin operation of a TRYP by Wyndham franchise for a 150 room conversion facility ranges from  $\frac{743,675}{1,284,641}$  to  $\frac{11,088,859}{112,255}$ . Land acquisition costs are not included in these ranges. $\frac{972,346}{22,346}$ . The above amounts include a range of  $\frac{112,255}{12,255}$  to  $\frac{261,465}{12,255}$  that must be paid to the franchisor or an affiliate.
