The franchisee will operate a business that promotes, markets, and sells specialty photographic products to individuals and groups that participate in youth sports and social and school events.

The total investment necessary to begin operation of a TSS Photography franchise ranges from \$35,940 to \$74,215. This includes initial fees ranging from \$32,890 to \$56,890 that must be paid to TSS Photography or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
