The franchise offered is for the operation of a business under the name "Tutor Doctor" which offers affordable tutoring services at a student's home. This franchise system or platform offers an effective alternative to students and parents who prefer to receive tutoring help in their own home instead of traveling to a learning center.

We currently offer three types of franchises: (a) a "Local Territory Franchise;" (b) a "Regional Territory Franchise;" and (c) a "National Territory Franchise." The total investment necessary to begin operation of these three types of franchises is: \$68,500 to \$96,700 for a Local Territory Franchise, which includes \$44,700 that must be paid to the franchisor and/or its affiliate; \$73,500 to \$101,700 for a Regional Territory Franchise, which includes \$49,700 that must be paid to the franchisor and/or its affiliate; and \$83,500 to \$111,700 for a National Territory Franchise, which includes \$59,700 that must be paid to the franchisor and/or its affiliate; and \$83,500 to \$111,700 for a National Territory Franchise, which includes \$59,700 that must be paid to the franchisor and/or its affiliate.

We also offer an "empire builder" program that includes one Regional Territory and two Local Territories. The total investment necessary to begin operation of an Empire Builder Franchise is \$113,200 to \$141,400, which includes \$89,400 that must be paid to the franchisor and/or its affiliate.
