As a franchisee, you will operate a tutoring business specializing in providing diagnostic testing, reading, writing and math tutoring, homework assistance and development of study skills.

The total investment necessary to begin operation of a Tutoring Club® franchise is between \$77,000 and \$142,400. This includes \$53,000 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of a Tutoring Club® Area Development franchise is between \$97,000 and \$182,400. This includes between \$73,000 and \$93,000 that must be paid to the franchisor or its affiliate.
