The franchise business provides local moving services and related services including packing and the sale of boxes and packing materials. You may purchase a single franchise or an area development franchise.

The total investment necessary to begin operations of a Two Men and a Truck franchise ranges from \$\frac{178,000}{173,000}\$ to \$\frac{583,500}{583,500}\$. This includes _, including \$\frac{50,000}{500}\$ to \$85,000 that must be paid to the franchisor or its affiliates as an initial franchise fee. The total investment necessary to begin operation of an area development franchise (including the investment for the first franchise developed) is \$275,500 to \$683,500. This includes \$150,000 to \$185,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all <u>accompanying</u> agreements carefully. You must receive this disclosure document at least 14 calendar_days before you sign a binding agreement <u>with</u>, or make any payment <u>to</u>, the <u>franchisor or an affiliate</u> in connection with the <u>proposed</u> franchise sale. <u>Note</u>, <u>however</u>, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. Information comparing franchisors is available. Call your state agency or your public library for sources of information.
