
Dear Mr. Sexton:

We have discovered that we may have inadvertently included last year's version of the Operations Manual Table of Contents in the unmarked version of the U-Swirl International, Inc. Franchise Disclosure Document submitted with the recent franchise registration application in your state. The marked version of the FDD correctly contained the current version of the Operations Manual Table of Contents, marked to last year's version of the Table of Contents. We also discovered a typographical error in the first sentence of Section 5.7.a of the Franchise Agreement, in reference to the interest rate on past due payments before a default (note that Item 6 of the FDD contains the correct information).

Accordingly, I have enclosed an unmarked version of the current version of the Operations Manual Table of Contents, and marked and unmarked versions of the applicable page in the Franchise Agreement.
