Una Mas Franchise Corporation, a California corporation, offers franchises for the operation of Una Mas restaurants at specified locations selling a menu featuring authentic Mexican food to order for dine in, takeout and delivery. We offer the rights for 2 different franchises in this Disclosure Document:

<u>Single Restaurant Program</u>. Under the Single Restaurant Program, you will sign a Franchise Agreement to operate a single Una Mas restaurant. The total investment necessary to begin operations of a single Una Mas restaurant ranges from approximately \$369,500 to \$614,000. This includes \$40,000 that must be paid to the franchisor or an affiliate.

<u>Area Development Program</u>. Under the Area Development Program, we will assign you a defined area within which you must develop and operate 3 or more Una Mas restaurants. The total investment necessary to begin operations of a single Una Mas restaurant under the Area Development Program ranges from approximately \$369,700 to \$614,500 per restaurant. This includes \$40,000 to that must be paid to us or our affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

IT MAY ALSO COST YOU MORE TO PARTICIPATE IN MEDIATION WITH UNA MAS FRANCHISE CORPORATION IN CALIFORNIA THAN IN YOUR HOME STATE.

2. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT STATE THAT CALIFORNIA LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3.
