The franchise offered in this Franchise Disclosure Document is for the operation of a kiosk, food truck, quick-service restaurant, or full-service restaurant serving a Hawaiian-Asian fusion menu item known as Poke, a raw fish salad found in Hawaiian cuisine, as well as hot and cold beverages, including Boba Milk Tea, and a deserts offering in some locations.

The total investment necessary to begin operation of an Uncle Sharkii Poke Bar kiosk (hereinafter, the "Uncle Sharkii Poke Bar Kiosk") is between \$75,000 and \$106,400. This includes an initial franchise fee of \$29,900 that must be paid to us or our Affiliates. The total investment necessary to begin operation of an Uncle Sharkii Poke Bar Kiosk area development franchise is between \$104,900 and \$174,950, which includes additional fees of between \$59,800 and \$89,700, which must be paid to us or our Affiliates.

The total investment necessary to begin operation of an Uncle Sharkii Poke Bar food truck (hereinafter, the "Uncle Sharkii Poke Bar Food Truck") is between \$93,490 and \$161,490. This includes an initial franchise fee of \$29,900 that must be paid to us or our Affiliates. The total investment necessary to begin operation of an Uncle Sharkii Poke Bar Food Truck area development franchise is between \$123,300 and \$216,200, which includes additional fees of between \$59,800 and \$89,700, which must be paid to us or our Affiliates.

The total investment necessary to begin operation of an Uncle Sharkii Poke Bar quick-service restaurant (hereinafter, the "Uncle Sharkii Poke Bar QSR") is between \$125,690 and \$192,490. This includes an initial franchise fee of \$29,900 that must be paid to us or our Affiliates. The total investment necessary to begin operation of an Uncle Sharkii Poke Bar QSR area development franchise is between \$155,500 and \$252,200, which includes additional fees of between \$59,800 and \$89,700, which must be paid to us or our Affiliates.

The total investment necessary to begin operation of an Uncle Sharkii Poke Bar full-service restaurant (hereinafter, the "Uncle Sharkii Poke Bar FSR" and together with the Uncle Sharkii Poke Bar Kiosk, the Uncle Sharkii Poke Bar Food Truck, and the Uncle Sharkii Poke Bar QSR the "Uncle Sharkii Poke Bar Businesses" or "Businesses" and each an "Uncle Sharkii Poke Bar Business") is between \$206,900 and \$324,490. This includes an initial franchise



fee of \$29,900 that must be paid to us or our Affiliates. The total investment necessary to begin operation of an Uncle Sharkii Poke Bar FSR area development franchise is between \$236,800 and \$394,200, which includes additional fees of between \$59,800 and \$89,700, which must be paid to us or our Affiliates.

This disclosure document summarized certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. QUESTION	WHERE TO FIND INFORMATION
How much can I earn?	Item 19 may give you information about outlet sales, costs, profits or losses. You should also try to obtain this information from others, like current and former franchisees. You can find their names and contact information in Item 20 or Exhibit E.
How much will I need to invest?	Items 5 and 6 list fees you will be paying to the franchisor or at the franchisor's direction. Item 7 lists the initial investment to open. Item 8 describes the suppliers you must use.
Does the franchisor have the financial ability to provide support to my business?	Item 21 or Exhibit D includes financial statements. Review these statements carefully.

in my area?

Will my business be the Item 12 and the "territory" provisions in the only Uncle Sharkii business franchise agreement describe whether the franchisor and other franchisees can compete with you.

Does the franchisor have a Items 3 and 4 tell you whether the franchisor or its management have been involved in material litigation or bankruptcy proceedings.
