The franchise offered is for the operation of either a fitness facility that offers boxing and kickboxing workouts in a group setting ("Express Model") or a fitness facility that offers boxing, kickboxing and a variety of other functional fitness programs on a one-on-one basis and also in group settings ("Standard Model") Both businesses are fitness facilities that incorporate our proprietary strength and conditioning workout routines for individuals who wish to improve their overall body fitness, under the name "Undisputed Boxing Gym™" Each model features our proprietary fitness programs and workout routines that are effective, positive and motivational The Initial Franchise Fee is \$20,000 for either an Express Model or a Standard Model franchise with protected rights to operate in a specific area as defined by us Additional franchises may be available for those franchisees who have bought at least one franchise, at a reduced fee of \$10,000 per Franchise The total investment necessary to begin the operation of an Undisputed Boxing Gym™ Express Model ranges from \$232,600 to \$364,300 and from \$315,150 to \$514,950 for an Undisputed Boxing Gym™ Standard Model This includes the Initial Franchise Fee of \$20,000 which is the same for either an Express Model or a Standard Model (as discussed in Item 5) that must be paid to the Franchisor or affiliate
