The total investment necessary to begin operation of a Uni K Wax Center franchise with 6 treatment rooms is \$257,400 to \$344,500, and with 7-9 treatment rooms is \$330,400 to \$425,500. This includes approximately \$48,500 to \$53,000 that must be paid to the franchisor or affiliate.

If you sign an Area Development Agreement, (he total initial investment ranges disclosed above will apply for each Uni K Wax Center you are required to open under your Area Development Agreement.
