Uni K Wax Centers offer to both men and women efficient body and facial hair removal using certain proprietary techniques and wax products and other various items that are only from Uni K Wax, its affiliates, or designees. Uni K Wax Centers are body and facial waxing specialists and offers only waxing services. Uni K Wax has offered franchises since October, 2006.

The total investment necessary to begin operation of a Uni K Wax Center franchise with 6 waxing rooms is \$272,700 to \$385,800, and with 7-9 waxing rooms is \$346,100 to \$459,300. This includes approximately \$54,000 to \$57,000 that must be paid to the franchisor or affiliate.

If you sign an Area Development Agreement, the total initial investment ranges disclosed above will apply for each Uni K Wax Center you are required to open under your Area Development Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale or grant. Note, however, that no governmental agency has verified the information contained in this document.

OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH UKW FRANCHISING COMPANY, LLC IN FLORIDA THAN IN YOUR OWN STATE.
