Uni K Wax® Centers offer to both men and women efficient body and facial hair removal using certain proprietary techniques and wax products and other various items that are only provided by UKW Franchising Company, LLC, its affiliates, or designees.

The total investment necessary to begin operation of a Uni K Wax® Center franchise ranges from \$181,250 to \$450,200, depending upon the size of the location and the type of market in which it is located. We have the following three types of Centers available: (i) Boutique/Non-Traditional: The total investment for a single Boutique/Non-Traditional Center ranges from \$206,250 to \$249,450. This includes \$49,700 to \$51,600 that must be paid to the franchisor or its affiliate; (ii) Mid-Market/Urban/Surburban: the total investment for a single Mid-Market/Urban/Surburban Center ranges from \$261,500 to \$323,600. This includes \$54,200 to \$57,100 that must be paid to the franchisor or its affiliate; or (iii) Large Market/Dense Metro: the total investment for a single Large Market/Dense Metro Center ranges from \$299,350 to \$450,200. This includes \$66,500 to \$72,900 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale or grant.
