We offer a franchise for the operation of a sales agency primarily offering business travel and conferencing services to small and mid-sized businesses.

The total investment necessary to begin operation of a Uniglobe Travel® business ranges from \$45,700 to \$61,500. This includes \$19,000 or \$16,150 in the case of an Honorably Discharged Veteran of the United States Armed Forces that must be paid to the Franchisor or its affiliate.
