A franchisee will conduct a real estate brokerage business or auction business at a single location as identified in the Franchise Agreement (the "Broker Office") using the United Country Real Estate Licensed Marks. Additional business locations must be the subject of grant in a separate Franchise Agreement.

The total investment necessary to begin operation of a United Country Real Estate Broker Office franchised business is \$16,690 to \$29,095 for a conversion office and \$26,300 to \$44,435 for a new office. This includes the \$15,000 initial Franchise Fee that must be paid to us.

This Disclosure Document summarizes certain provisions of the Franchise Agreement and other information in plain English. Read this Disclosure Document and all agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this Disclosure Document.**

- (1) THE FRANCHISE AGREEMENT REQUIRES YOU TO ARBITRATE WITH US ONLY IN KANSAS CITY, MISSOURI. HOWEVER, WE MAY SEEK INJUNCTIVE RELIEF FOR THE UNAUTHORIZED USE OF THE LICENSED MARKS AND YOU OR US MAY SUE FOR MONEY OWED IN ANY COURT HAVING JURISDICTION. OUT OF STATE ARBITRATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN MISSOURI THAN IN YOUR HOME STATE.
- (2) THE FRANCHISE AGREEMENT STATES THAT MISSOURI LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- (3) FRANCHISOR HAS A LIMITED FRANCHISE OPERATING HISTORY TO ASSIST A PROSPECTIVE FRANCHISEE IN DECIDING TO MAKE THIS INVESTMENT.
- (4) YOU MUST MAKE MINIMUM ROYALTY PAYMENTS, REGARDLESS OF YOUR SALES LEVELS. FAILURE TO MAKE THE PAYMENTS MAY RESULT IN TERMINATION OF YOUR FRANCHISE AND LOSS OF YOUR INVESTMENT.
- (5) PLEASE NOTE THAT 90% OF THE FRANCHISOR'S ASSETS ARE INTANGIBLE. YOU MAY WANT TO TAKE THAT INTO CONSIDERATION WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPORTUNITY.
- (6) THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
