We offer two restaurant concepts. One concept is a full service casual theme restaurant under the name Uno Chicago Grill® which features "Chicago Style" deep dish pizza along with steaks, ribs, seafood, sandwiches, salads, pasta, appetizers, desserts and a full bar, subject to applicable law. The other concept is a fast casual style restaurant under the name Uno Due Go® which features deep dish pizza and a wide variety of sandwiches, salads, appetizers, breakfast offerings, desserts and beverages. This disclosure document describes the offer of a Full Service Uno Chicago Grill® Restaurant franchise.

The estimated total investment necessary to begin operation of a Full Service Uno Chicago Grill® Restaurant is \$1,706,000 to \$2,435,500 if you operate from a built to suit or leased building and real estate. This includes a \$40,000 Initial Franchise Fee that must be paid to us. The total investment necessary to begin operation of a Full Service Uno Chicago Grill® Restaurant is \$2,111,500 to \$3,346,500 if you own the restaurant building and lease the real estate. This includes a \$40,000 Initial Franchise Fee that must be paid to us.

We offer development rights for Full Service Uno Chicago Grill® Restaurants and Uno Due Go Restaurants. If you enter into a Development Agreement, you must, when you sign the Development Agreement, pay us a development fee equal to \$10,000 times the number of Restaurants you will own and operate. The development fee does not apply toward the Initial Franchise Fees you will pay for each Restaurant. In addition to the development fee, you must pay us an Initial Franchise Fee of \$40,000 for each Full Service Uno Chicago Grill® Restaurant. You must pay one-half of the total amount of the Initial Franchise Fees which are \$20,000 per restaurant times the number of Full Service Uno Chicago Grill® Restaurants you will own and operate, when you sign the Development Agreement, and you will pay the remaining one-half of the Initial Franchise Fee for each restaurant when you sign the Franchise Agreements (see Item 5).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
