The total investment necessary to begin operation of a USA Insulation franchise ranges from \$159,750148,704 to \$190179,500. This includes approximately \$61,081 to \$63,081 in fees that must be paid to the franchisor prior to opening.

- THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source is <u>our</u> agent and represents us, not you. We pay this person a fee for selling our franchise or referring you to us.
