Health One Management Company, doing business as UVANTA Healthcare, offers franchises for the operation of UVANTA[®] pharmacies ("Pharmacies"), selling pharmaceuticals and pharmaceutical-related items and services to long-term health care facilities.

The total initial investment necessary to begin operation of a UVANTA[®] Pharmacy is \$282,000 to \$540,000. This includes \$43,950 to \$53,709 that must be paid to the franchisor or affiliate.
