The total investment necessary to convert and begin operation of a VAGABOND INN or VAGABOND INN EXECUTIVE 65-100m, 2-story hotel ranges from \$161,000 to \$555,000 This includes \$10,000 that must be paid to the franchisor This estimate does not include the cost of acquiring the hotel and other costs that you incurred before signing the franchise agreement. If you build a new 100-room, 3-story hotel, the estimated initial investment ranges from \$4,957,500 to \$7,093,000. This also includes \$10,000 that must be paid to the franchisor. The estimated initial investment required will vary for a larger or smaller hotel.
