As a VAGABOND INN<sup>®</sup> or VAGABOND INN EXECUTIVE<sup>®</sup> franchisee, you will operate a limited service, economy motel or hotel

The total investment necessary to convert and begin operation of a VAGABOND INN or VAGABOND INN EXECUTIVE 65-100m, 2-story hotel ranges from \$161,000 to \$555,000 This includes \$10,000 that must be paid to the franchisor This estimate does not include the cost of acquiring the hotel and other costs that you incurred before signing the franchise agreement If you build a new 100-room, 3-story hotel, the estimated initial investment ranges from \$4,957,500 to \$7,093,000 This also includes \$10,000 that must be paid to the franchisor The estimated initial investment required will vary for a larger or smaller hotel

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, franchisor or an affiliate in connection with the proposed franchise sale **Note, however, that no government agency has verified the information contained in this document**
