The primary purpose of the franchised business is a building cleaning business.

The total investment necessary to begin operation of a Valcourt franchised business is from \$14,350 to \$20,100. This includes \$10,000 that must be paid to the franchisor and affiliates.

You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

1. VALCOURT AND YOU MAY NEGOTIATE CONTRACTS, BUT VALCOURT WILL BE THE CONTRACTING PARTY WITH THE CUSTOMER FOR ALL CONTRACTS. YOU ARE NOT ALLOWED TO ENTER INTO YOUR OWN CONTRACTS FOR SERVICES. VALCOURT DETERMINES THE PRICES THAT WILL BE PAID FOR YOUR SERVICES. YOU MUST DETERMINE IF YOU CAN PROVIDE THE REQUIRED SERVICES, PAY THE ASSOCIATED LICENSE FEE, PAY YOUR BUSINESS EXPENSES AND STILL MAKE A WORTHWHILE PROFIT.
2. VALCOURT HAS NO OBLIGATION TO OFFER YOU A MINIMUM NUMBER OF WORK ORDERS, WORK ORDERS THAT ARE CONVENIENT TO YOUR EXISTING WORK OR WORK ORDERS THAT MAY BE PROFITABLE TO YOU. ALSO, IF YOU DO NOT ACCEPT 75% OF THE WORK ORDERS OFFERED DURING ANY CALENDAR QUARTER, YOUR FRANCHISE MAY BE TERMINATED.
3. THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS BE SETTLED BY LITIGATION IN THE COMMONWEALTH OF VIRGINIA. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN OUR HOME STATE THAN IN YOUR HOME STATE.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
