The Franchise Business you will own and operate is a business offering electronic cigarettes, e-liquids, nicotine, vaporizers, accessories and other related items, under the VaporFi name, service mark and System.

The total investment necessary to begin operation of a VaporFi Franchise Unit ranges from \$137,200 to \$292,700. This includes \$70,400 to \$91,900 that must be paid to us or our affiliate.

We also offer to certain qualified persons rights to develop a specified number of VaporFi Franchises (the "Franchise Businesses") within a Development Area under a VaporFi Area Development Agreement. You must pay us a Development Fee equal to the Initial Franchise Fee for the first Shop(\$29,900) and \$14,950 each for the 2nd and 3rd Shop and \$7,475 each for the 4<sup>th</sup> and each additional Shop that you are required to open during the term of the Area Development Agreement. The Development Fee is due and payable upon signing the Area Development Agreement. You will receive a corresponding credit against the Initial Franchise Fee for each Shop, after the first Shop opened under the Area Development Agreement. The balance of the Initial Franchise Fee for each Shop opened under the Area Development Agreement must be paid upon signing the Franchise Agreement required for that Shop. We do not refund the Development Fee under any circumstances.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to us or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this Franchise Disclosure Document.**
