FRANCHISE DISCLOSURE DOCUMENT

The franchise being offered is for a Village Inn restaurant. Village Inn is a sit-down family dining concept. It features a variety of menu items for all meal periods, but specializes in pancakes, omelets, skillets, eggs, and other popular breakfast items.

The total investment necessary to begin operation of a single Village Inn restaurant franchise is \$941,200 to \$2,460,700. This includes an initial franchise fee of \$40,000 and the cost of prototypical plans and specifications for your restaurant (ranging from \$15,000 to \$100,000) that must be paid to us or an affiliate.

If you obtain development rights to develop, open and operate more than one Village Inn Restaurant, pursuant to a development agreement, you must pay a development fee equal to the total of the initial franchise fee for the first location (\$40,000) plus \$10,000 for each additional Restaurant to be developed, but we will credit the entire initial franchise fee for the first Restaurant and \$10,000 towards the initial franchise fee for the second and each additional Restaurant to be developed under the development agreement if you are then in compliance when you sign your franchise agreements.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your Disclosure Document in another format that is more convenient for you. The terms of your contract will govern your franchise relationship. Do not rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN TENNESSEE THAN IN YOUR OWN STATE.

(2) THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT STATE THAT TENNESSEE LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

(3) THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
