The franchise being offered is for a Village Inn restaurant. We may also offer you the right to acquire and operate one or more existing Village Inn restaurants from us or our affiliates (each a “Company Franchise Initiative Restaurant”). Village Inn is a sit-down family dining concept. It features a variety of menu items for all meal periods, but specializes in pancakes, omelets, skilletts, eggs, and other popular breakfast items.

The total investment necessary to begin operation of a single Village Inn restaurant franchise is \$964,000 to \$2,575,000. This includes an initial franchise fee (\$40,000) and the cost of prototypical plans and specifications (\$15,000) that must be paid to us or an affiliate. The total investment necessary to begin operation of a single Village Inn Company Franchise Initiative Restaurant is \$205,000 to \$765,000 (excluding the asset purchase price). This includes an initial franchise fee (\$40,000) that must be paid to us or an affiliate, but excludes the asset purchase costs that will vary.

If you obtain development rights to develop, open and operate more than one Village Inn Restaurant, pursuant to a development agreement, you must pay a development fee equal to the total of the initial franchise fee for the first location (\$40,000) plus \$20,000 for each additional Restaurant to be developed, but we will apply a credit to the entire initial franchise fee for the first Restaurant and \$20,000 towards the initial franchise fee for the second and each additional Restaurant to be developed under the development agreement if you are then in compliance when you sign your franchise agreements.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

You may wish to receive your Disclosure Document in another format that is more convenient for you.
