VISION TRENDS.

A Vision Trends licensee provides optometry services, and sells prescription lenses, eye glass frames, contact lenses, and related products and services.

The total investment necessary to begin operation of a Vision Trends business is \$3,200 to \$30,500 for a conversion store (if you already own an optometry business) and \$160,200 to \$427,500 for a new store (if you do not already own an optometry business). This includes a \$500 administrative fee that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your license agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed license sale. **Note, however, that no government agency has verified the information contained in this document.**
