You will operate a Franchised Business which provides non-medical home care giving services to elderly or convalescing clients in their homes. The total investment necessary to begin operation of a Visiting Angels franchise is \$60,750to \$98,500. This includes \$34,950 to \$57, 950 that must be paid to the franchisor or affiliate. The Initial Franchise Fee for a VISITING ANGELS franchise is \$34,950 for a protected territory of up to 100,000 population, \$42,950 for a protected territory of up to 200,000 population, \$57,950 for a protected territory of up to 325,000 population (additional protected territory in amounts greater than 200K population and less than 325K population may be purchased for an additional \$2,150 for each additional 10,000 population). This sum does not include rent for a business location but does include working capital for the first year.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Do not rely on the disclosure document alone to understand your contract. Read your entire contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. More information on franchising, such as "<u>A Consumer's Guide to</u> <u>Buying a Franchise</u>," which can help you understand how to use this disclosure document, is

- 1. THE FRANCHISE AGREEMENT PERMITS YOU TO ARBITRATE WITH US OR TO SUE US ONLY IN OUR HOME STATE OF PENNSYLVANIA. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR SUE IN OUR HOME STATE THAN IN YOUR HOME STATE. THIS RISK FACTOR IS NOT APPLICABLE IN THE STATE OF MARYLAND.
- 2. THE FRANCHISE AGREEMENT STATES THAT PENNSYLVANIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
