The franchisee will operate a patient care business specializing in services and associated professional services for administration of related healthcare, utilizing the service mark "Vital Care."

The total investment necessary to begin operation of a Vital Care franchise is \$57,500 to \$207,300. This includes \$25,000 that must be paid to franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.** 

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. - 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN ALABAMA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN ALABAMA THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT ALABAMA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE LAWS.
- 3. YOU MUST PAY US MINIMUM ROYALTY FEES OF \$500 EACH MONTH, BEGINNING THE 13<sup>TH</sup> MONTH AFTER THE DATE OF THE FRANCHISE AGREEMENT, EVEN IF THE FRANCHISE BUSINESS HAS NO REVENUE.
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
