The franchisee will operate a patient care business specializing in services and associated professional services for administration of related healthcare, utilizing the service mark "Vital Care."

The total investment necessary to begin operation of a Vital Care franchise is \$83,200 to \$241,600. This includes \$40,000 that must be paid to franchisor or affiliate.

- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
