The franchisee will operate a patient care business specializing in services and associated professional services for administration of related healthcare, utilizing the service mark "Vital Care."

The total investment necessary to begin operation of a Vital Care franchise is \$99,200 to \$282,700. This includes \$40,000 that must be paid to franchisor or affiliate.

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN ALABAMA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN ALABAMA THAN IN YOUR HOME STATE.
2. THE FRANCHISE AGREEMENT STATES THAT ALABAMA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE LAWS.
3. YOU MUST PAY US MINIMUM ROYALTY FEES OF \$500 EACH MONTH, BEGINNING THE 13TH MONTH AFTER THE DATE OF THE FRANCHISE AGREEMENT, EVEN IF THE FRANCHISE BUSINESS HAS NO REVENUE.
4. YOU MUST MAINTAIN MINIMUM SALES PERFORMANCE LEVELS. YOUR INABILITY TO MAINTAIN THESE LEVELS MAY RESULT IN LOSS OF ANY TERRITORIAL RIGHTS YOU ARE GRANTED, TERMINATION OF YOUR FRANCHISE, AND LOSS OF YOUR INVESTMENT.
5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
