Vitality Bowls restaurants operate superfood cafes offering high-quality, healthy, great-tasting, and affordable Acai bowls, invigorating smoothies, delicious Panini's, and other healthy food options ("Vitality Bowls Restaurant(s)")

The estimated total investment necessary to begin operations for a Vitality Bowls Restaurant ranges from \$154,100 and \$563,500 This includes between \$29,500 and \$39,500 that must be paid to the franchisor or its affiliates

Vitality Bowls area developers acquire the right to develop multiple Vitality Bowls Restaurants in a designated development area. The development fee is \$39,500 for the first Restaurant to be developed under the Area Development Agreement, plus \$29,500 for the second and each subsequent Restaurant to be developed under the Area Development Agreement. The total investment necessary to begin operation of a $\bar{\text{Vitality}}$ Bowls area developer business will depend on the number of Vitality Bowls Restaurants to be opened
