VivoPools Franchise Company, LLC grants franchises for businesses which provide pool maintenance, remodeling and repair services under the “VivoPools” trade name and service mark and spa maintenance, remodeling and repair services under the “VivoSpas” trade name and service mark. We offer 2 franchise programs

**New Franchised Business Program** You will sign a Franchise Agreement to operate a pool maintenance, remodeling and repair business or a spa maintenance, remodeling and repair business (each, a “**Franchised Business**”), in a designated zip code or zip codes that we approve. The total investment necessary to begin operation of one Franchised Business is approximately \$19,980 to \$98,300, which includes \$16,400 to \$66,800 that must be paid to us or our Affiliate.

**Conversion Program** The total investment necessary to begin operation of a converted Franchised Business ranges from \$10,200 to \$92,300, which includes \$8,000 to \$60,800 that must be paid to us or our Affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or its affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
