We offer franchises for operation of vomFASS® retail stores for stand-alone retail stores and shop-in-shops. vomFASS® retail stores sell liqueurs, wines, spirits, spices, vinegars and oils from bulk casks and amphora that allow customers to sample the products prior to purchase. Where local or state alcoholic beverage regulations restrict alcohol sales or make it impracticable, we offer side-by-side stores which offer liqueurs, wines and spirits in one space and oils, vinegars and spices in an adjacent or nearby space or stores featuring oils, vinegars and spices without the alcohol products under the Violas'® store brand.

The total investment necessary to begin operation of a vomFASS® or Violas'® retail store franchise is between \$252,300 and \$749,500 not including real estate and liquor license for a vomFASS store. This includes between \$150,500 and \$237,000 that must be paid to the franchisor or its affiliate. We also offer a vomFASS franchise for a shop-in-shop. Shop-in-shop stores feature oils, vinegars and spices without the alcohol products. The total investment necessary to begin operation of a vomFASS® shop-in-shop franchise is between \$96,750 and \$264,750 (not including real estate). This includes between \$70,250 and \$153,250 that must be paid to the us or our affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale or grant. Note, however, that no governmental agency has verified the information contained in this document.

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION OR ARBITRATION ONLY IN NEW YORK CITY, NEW YORK. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO MEDIATE OR ARBITRATE WITH US IN NEW YORK CITY, NEW YORK THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT DELAWARE LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

THIS REQUIREMENT PLACES THE PERSONAL ASSETS OF THE FRANCHISE OWNER(S) AND SPOUSE(S) AT RISK.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of this franchise.
