 Item 13 of the Franchise Disclosure Document and the applicable sections of franchise agreement(s) must state that the franchisor will protect the franchisee's right to use the trademarks, service marks, trade names, logotypes or other commercial symbols or indemnify the franchisee from any loss, costs or expenses arising out of any claim, suit or demand regarding the use of the name.

Minnesota considers it unfair to not protect the franchisee's right to use the trademarks. Refer to Minnesota Statutes, Section 80C.12, Subd. 1(g). Please amend accordingly.

• 2. The Limitations of Claims section must comply with Minnesota Statutes, Section 80C.17,
Subd. 5. Please amend.

In responding to the above deficiencies, please submit only the marked pages (one set).

The Commissioner may withdraw an application in which no activity has occurred for 120 days (Minnesota Statutes, Section 80C.05, Subd. 4). If an Order of Withdrawal is issued, the franchisor must reapply with a new application.
