The franchise business is an upscale men's barbershop that provides high-quality haircuts, old-fashioned shaves and men's facial services in a uniquely masculine environment under the V's Barbershop® service marks and trademarks.

The total investment necessary to begin operation of a V's Barbershop® is between ~~\$170,500~~169,250 and ~~\$294,500~~334,250. This includes ~~\$25,000 to \$30,000~~ for the initial franchise fee, and between ~~\$9,000~~19,500 and ~~\$42,000~~41,000 for initial inventory ~~and between \$84,000 and \$138,000 for~~ furniture, fixtures, and equipment, ~~computer hardware and software and signage that the franchisor will arrange for you to~~ you must purchase, which amounts must be paid to the exclusively from the franchisor or franchisor's approved vendors its affiliates.
